

**Harvard system citation manual**  
**Harvard references format 1 (deprecated; 2017)**  
**Cite Them Right 12th edition – Harvard (2022)**

Harvard citation style originated in the US at Harvard University (Cambridge, MA). Please do not confuse with University of Cambridge, (Cambridge, UK). This is an author-date style. This means that in the main text in parentheses there is only: 1) the author's name (maximum of three), 2) the year of publication, and 3) the cited page or page range. The bibliography (must be specified with the English word: References) is arranged alphabetically (by name and year of publication). Please do not number the bibliography, also do not divide it into sections (monographs, chapters in books, articles, and especially netography). Web pages also have authors and year of publication. Below (point 4) is a description of how to cite web pages. Bibliography managers do this automatically. If someone does not use such managers, they have to do it manually.

## 1. Monographs

## **4. Websites**

Web pages are constructed differently. Record fields are not always properly labeled. Therefore, bibliography managers cannot retrieve important information (author/authors name and year). In such situations, you need to enter the relevant information in the appropriate fields.

### **4.1. Website with author, year and citation of document numbers**

In the text: (Benedict XVI, 2009, no. 12)

The author is "Benedict XVI"; this is a personal name. This should be entered in the "name" field.

In the bibliography:

The author is „Congregation for the Doctrine of the Faith”; this is a proper name. This should be entered in the „name” field.

#### 4.3. A website whose “author” is the name of the server

In the text: (MyPlan.com, 2004)

The author is “MyPlan.com”; this is the author’s own name. This should be entered in the “name” field. The date is at the bottom of the page.

In the text: (Avvenire.it, 2022)

The author is “Avvenire.it”; this is the author’s own name. This should be entered in the “name” field.
